# TENDER RELATING TO DELIVERY OF AN AGE GROUP AND ELITE INTERNATIONAL EVENT FOR

#### TRIATHLON IRELAND

#### About Triathlon Ireland

Our primary responsibility is the development, promotion and safeguarding of the sport of triathlon in Ireland. We do this, in collaboration with our network of strong affiliated clubs and event organisers, through the sanctioning of triathlon related events throughout Ireland; and through developing systems and structures for athletes of all levels from Novice to Elite to participate in the sport.

## Detailed description:

Triathlon Ireland proposes to establish an agreement for the provision of event management services to deliver a standalone event in 2024(with a view to a longer term arrangement) which will incorporate age group, youth and elite international triathlon racing. The primary objective of this tender is to secure a commercial partner for all operational delivery aspects of the event, in keeping with the regulations and guidelines specified by Triathlon Ireland, Europe Triathlon, and the rules and regulations of World Triathlon.

The vision is that this event will become one of the biggest triathlon events on the island, with mass participation, elite and youth athletes all coming together for a 1 or 2 day event that delivers an exceptional experience for all. It will at minimum break even in Year 1, with strong income development potential in Years 2 and 3.

Triathlon Ireland will provide significant operational resources to support the bidding process and the event delivery. The structure of the Local Organising Committee will ideally be made up of Triathlon Ireland, the Host Event, and the relevant Local Authority.

The Europe Triathlon Cups will be part of and will count towards the European Elite, U23 and Junior Europe Triathlon rankings and as such will be likely to attract the best European athletes to Ireland.

The event will receive exposure on Triathlon Ireland's digital platforms, triathlon.org and official World/Continental Triathlon social media channels via news stories, photo galleries and results.

## Scope of Works:

This document is intended for interested parties to supply and deliver event management services for Triathlon Ireland.

The services include but not limited to:

- Project Management
- Budget Management
- Course design and planning
- Liaising with key stakeholders to deliver event
- Organisation of road closures
- Organisation and support in recruitment of marshalls and volunteers
- To create an engaging spectator experience

The service will include the delivery of the following:

- Europe Triathlon Cup
- Europe Triathlon Junior Cup
- Triathlon Ireland National Series Triathlon Event(Mass Participation)
- Junior National Series Triathlon Event and/or
- Draft Legal Youth Series Triathlon
