I would like to apply for the position of Vice President this year.

I held the position of Ordinary Director on the Triathlon Ireland Board from 2016 to 2020.

I did my first multi-sport event in Florida in 1994 and have loved it ever since.

I moved to Ireland in 2001 with my wife, we have lived in West Cork ever since.

In 2004 I participated in the Fastnet Triathlon, which I have been the race director of for the past 8 years. This year celebrates its 20th anniversary, and we are proud to return as part of the National Series this year.



I have held several separate roles with the Schull Triathlon Club over the years including chairperson, child protection officer, and treasurer.

I raced Age Group for Ireland in the European championships Duathlon 2011.

The same year I also started as a Technical Official for TI, mostly officiating at small races. In 2013 I was a TO for the ETU Junior EU Cup in Athlone, which inspired me to further my Technical Official education. I am now one of only two Irish level 2 World Triathlon TOs and have officiated at many international events, including Hamburg ITU world series 7 times, ITU World Triathlon Grand Final in Lausanne, as well as several international races in Montreal, Turkey, Zofingen, over the years.

I was asked to take on the role of Munster TO Secretary in 2014 and have been responsible for running TO Courses and allocating TOs for all races in Munster ever since.

In 2018 I became a mentor for TI's new TO's and coaches.

I bring a lot of experience to the table and after 27 years in multisport I still have a love for triathlon.

Over the past twenty-three years I have been involved in local sports facilities development, including refurbishing the basketball and tennis courts in Ballydehob and Schull.

As a Coxswain and officer in the Irish Coast Guard I conduct frequent risk assessments and human resource responsibilities.
